Article III, Section 12, of the Caroline County Forest Conservation Ordinance establishes a list of activities that are EXEMPT from the County's Forest Conservation Ordinance provided the owner files a Declaration of Intent with the Planning, Codes and Engineering Department assuring compliance with all requirements of the Forest Conservation Act. Based upon the information provided by the property owner, stating that the property will be used for commercial forestry purposes, it has been determined that the proposed activity is EXEMPT from the County's Forest Conservation Ordinance. Activities permitted under this EXEMPTION include commercial logging and subsequent forest management operations such as shearing, bedding, piling, windrowing, burning, pre-commercial thinning, construction or maintenance of timber haul roads, and construction and maintenance of associated ditches.

DECLARATION OF INTENT

I hereby affirm that this subject parcel will be used for the proposed activity stated above and that no regulated activity shall occur on the subject parcel within five (5) years of the effective date of this Declaration of Intent without compliance with the Caroline County Forest Conservation Ordinance.

I understand and agree that:

- A. The conditions upon which this Declaration were granted may not be changed without the express approval of the Caroline County Planning, Codes & Engineering Department; and
- B. Any regulated activity, as defined in the Caroline County Forest Conservation Ordinance, that is not the subject of this Declaration of Intent, will require separate approval.
